County to require permits for special events

McIntosh County Commissioners presented to first reading at its May meeting on May 14 for a Special Event Ordinance that will require application of a permit by any person, group, organization, association, club or other entity conducting any special event in unincorporated McIntosh County.

County Manager Patrick Zoucks said that several commissioners and the Office of the Sheriff had requested the county have a special event ordinance in place to allow the county to know what is going on and to ensure the county is properly prepared to handle the event.

The proposed ordinance defines a special event as any organized activity having as its purpose entertainment, recreation and/or education, such as a festival or celebration, foot or vehicle race, parade or march, rally or assembly, which takes place on a public street, sidewalk, or right-of-way, or occurs on private property and impacts government services on public rights-of-way.

Exemptions from required special event permit are if the special event expects less than 75 people; occurs at a private residence, in which is hosted by at least one of the occupants of the residence; event occurring a city or county-owned sports facility in which it is intended to be used, regardless of the number of attendees; an event hosted by a church on property owned by the church; events hosted by a school on property owned by the school or a governmental entity; funeral processions under supervision of a funeral director; or a governmental agency acting within the

Tentative budget for county schools shows 1.6% increase from last year

A tentative budget for FY25 of \$18,788,243 was adopted by the McIntosh County Board of Education on May 13, which is a 1.6% increase from the FY24 Budget of \$18,488,166.

Financial Officer Tammy Franklin presented the budget to the board.

"Salaries and benefits comprise 78% of the anticipated expenditures and the remaining 22% of the expenditure budget includes other operating costs.

Salary increases for certified staff will be \$2,500 across all levels of the state salary scale, and non-certified salary scale has increased of 4%.

Employer State health insurance premiums will increase for both certified and non-certified

staff. Franklin told the board that certified staff insurance premiums increased to \$21,120, up from \$18,960; and non-certified staff increased to \$17,420, up from \$13,340.

Teacher's retirement rate is increased to 20.79%, up from 19.98%. Also, Franklin noted, a second grade teacher position has been added.

FY25 state QBE funding of \$8,159,298 is a 5.5% increase over the FY24 initial QBE allotment. This funding increase is to support the mandated salary and benefit increases.

State funding accounts for 45% of budgeted revenues. Local taxes and revenues account for the remaining 55%.

Franklin explained,

"Property taxes are based on the 2023 tax digest, which includes the millage rate of 16.2 and the property tax collection rate has been increased to 94% for estimating the FY25 tax revenue.

The federal ESSER ARP funds provided to help reopen schools during and after the pandemic are no longer available for FY25. Last year, the funding was \$1,292,298.

Additional funds included in the FY25 Budget are: School Nutrition, \$1,294,691; ESPLOST Projects, \$850,000; and Debt Service payments on the energy lease of \$1,219,922 for a total Consolidated Budget of \$22,152,856.


Public hearings are scheduled for Monday, June 3, and Monday, June

10, at 6 p.m. at the McIntosh County Board of Education office. The budget will be considered for final adoption at the regular session meeting on June 10 at 6 p.m.

In other business, the School Board approved the Superintendent's recommendations for the resignation of Heather Donn, MCMS Business Teacher, effective June 6; transfer of Alisha Durrant, TGES Teacher to MCA Science Teacher, effective July 31; new hire of Stephanie Largent, School Psychologist, effective July 22; Nicole Rigdon, TGES Teacher, effective July 31; and Emily Waddel, TGES Teacher, effective July 3.
